HANSON COUNTY COMMISSIONERS MINUTES OF PROCEEDINGS Tuesday, May 7, 2024

Chairman Fox with members Bumgardner, Kjetland, Schoenrock and Waldera present, called the regular meeting of the Hanson County Board of Commissioners to order on Tuesday, May 7, 2024.

The pledge of allegiance was recited.

Motion Bumgardner, seconded by Waldera to approve the agenda with no conflict of interest. Motion carried.

Motion Waldera, seconded by Schoenrock to approve the meeting minutes from April 16, 2024. Motion carried.

Commissioner Kjetland reported that he and Commissioner Fox received an email from SDSU Extension to vote on a candidate of their choice to fill the position of 4-H Youth Advisor in Hanson County. Nothing further has been heard from the state since.

Commissioner Waldera spoke during citizen input about the dangerous intersection and hidden driveway signs that have been installed south of Alexandria on 421st Ave. Legal advice on these signs will be asked when the States Attorney is present later in the meeting.

The Auditor's account balanced with the Treasurer in the amount of \$5,790,112.48 in all county, state, civil, school, CD and trust accounts as of April 30, 2024.

Register of Deeds fees collected for April 2024 totaled \$5,908.25.

Ronnie Roth, Hwy Superintendent, reported that in the original contract the County is responsible to repair any drain tile that is damaged during the removal of gravel at the Schmeichel pit. The quoted cost to repair the tile will be between \$3,700.00 and \$5,000.00. The repairs will be made and the tile will be routed so it will not be affected in future mining.

The 2019 JD Motor Grader is currently having warranty repairs done and expenses in the amount of approximately \$600.00 were approved to do the valve readjustment now while it's already in the repair shop and torn apart. Roth will be contacted if anything further is found that needs to be repaired or replaced.

Purchasing gravel was again discussed. Doug Werning offered \$2.00 a ton royalty but not knowing how much rock will need to be added to meet specs, this price is still too high. An advertisement of bids for stockpiled gravel that meets our specs will be published.

As the railroad crossing on 257th St. is being replaced, BNSF railroad contacted the County asking if they would like to contribute \$72,000.00 to make the crossing concrete. The offer was declined. The County will do what is needed to the gravel road once the new crossing is installed.

Motion Kjetland, seconded by Bumgardner to recess Board of Commissioners to convene as the Drainage Board. All voted aye, motion carried.

Reconvene Board of Commissioners.

Motion Waldera, seconded by Schoenrock to approve A PLAT OF LOT C OF PATZLAFF'S ADDITION IN THE SE4 OF THE NE4 OF SECTION 36, T 104 N, R 58 W OF THE 5TH PM, HANSON COUNTY, SD. All voted aye, motion carried.

As advertised, bids were opened for the surplus property in Emery described as Fahy's Addn Block 1 E 8' W 100' Lots 1-2-3. Two bids were submitted, Harold and Tania Wipf, \$1,000.00 and Brad Wollman, \$300.00. Wollman was then given the opportunity to raise his bid and ending with Wipf's high bid of \$1,600.00. Motion Waldera, seconded by Schoenrock to accept the bid of \$1,600.00 from Harold and Tania Wipf. All voted aye, motion carried.

Jim Davies, States Attorney, joined the meeting. Davies was asked and stated that posting the new signs on 421st Ave. is not a detriment to the county. The Hwy Superintendent has the authority to post any signs as a warning to drivers.

Davies informed the Board that an Admission of Service was signed concerning litigation against the County and gave an update on a pending case. The vacated street

property of the courthouse was again discussed and Davies will continue to work on this.
