HANSON COUNTY COMMISSIONERS MINUTES OF PROCEEDINGS Tuesday, July 2, 2024

Chairman Fox, with members Bumgardner, Kjetland, Schoenrock and Waldera present, called the regular meeting of the Hanson County Board of Commissioners to order on Tuesday, July 2, 2024.

The pledge of allegiance was recited.

Motion Bumgardner, seconded by Waldera to approve the agenda as amended. Motion carried.

Motion Kjetland, seconded by Waldera to approve the June 18th meeting minutes. Motion carried.

No board reports or citizen input.

Eric Prunty, Brosz Engineering, presented for approval the Design Acceptance documents for bridge #040-141 located on 416th Ave. over the James River. Motion Kjetland, seconded by Bumgardner to approve and authorize the Chairman to sign the Design Acceptance document. All voted aye, motion carried.

Eric also gave an update on the preservation grant work being done on the Old Mill Road bridge indicating that the contractor will start the work on July 8th with the completion date of November 1st still being met. A final inspection will be done after the preservation work has been completed.

Motion Waldera, seconded by Kjetland to postpone acceptance of a gravel bid until August 6, 2024 as Werning's conditional use permit was postponed at the June Zoning meeting. All voted aye, motion carried.

Motion Kjetland, seconded by Schoenrock to recess Board of Commissioners to conduct business as the Drainage Board. Motion carried.

Reconvene Board of Commissioners.

Brandon Wingert, Emergency Manager and Ronnie Roth, Hwy Superintendent, presented a map of flooding throughout the County and reviewed several of the most severely damaged roads and bridges. They reported approximately 68 flooded sites on County roads with six roads being closed completely. Motion Kjetland, seconded by Bumgardner to approve the following Disaster Declaration in hopes of receiving Federal funds to repair the damage. All voted aye, motion carried.

HANSON COUNTY DISASTER DECLARATION

WHEREAS, Hanson County, SD on June 20, 2024 through June 23, 2024 suffered flood damage;

WHEREAS, this rain (8 plus inches in areas) over 2 days, June 20, 2024 and June 21, 2024 caused severe flooding which many of the roads in Hanson County had been flooded and some of them received more flooding and damage making them impassable. The James River is over its banks and causing damage. Numerous farm fields are under water and several homes received water damage.

NOW BE IT RESOLVED that Hanson County Commissioners do hereby declare a disaster for the population of the area impacted.

BE IT FURTHER RESOLVED the Hanson County Commissioners respectfully request that all assistance that may be available from State and Federal agencies be provided to all local governments to include Hanson County and to local businesses and the general population as we work to overcome this disaster.

BE IT ALSO RESOLVED THAT the Hanson County Board of Commissioners do hereby declare a flooding disaster and respectfully request the Governor of the State of South Dakota declare a

disaster and to request a Presidential Declaration of Disaster to ensure that the maximum amount of assistance be made available to local governments, businesses and residents affected.
